POSITION SUMMARY:

Duties of this position include the application of knowledge of the Weatherization program, its work standards and technical requirements. Work well with fellow Weatherization staff members and the public. Interpret and follow written work orders. Install Weatherization retrofit construction air sealing (such as doors, windows, and general air sealing measures), insulation, minor plumbing, minor electrical, and minor HVAC materials and equipment measures in client's homes. Safely operate power tools and any equipment associated with job requirements. This position requires the use of a respirator.

SPECIFIC RESPONSIBITIES:

- Maintain a safe and healthy work environment for Agency employees, subcontractors, and clients (both on-site and at Agency facilities) and ensure all health and safety rules, regulations, guidelines and best-practices are followed at all times.
- 2. Understand, interpret and follow work orders.
- Possess ability to install Weatherization retrofit construction air sealing (such as
 doors, windows, and general air sealing measures), insulation, minor plumbing,
 minor electrical, and minor HVAC materials and equipment measures in client's
 homes.
- 4. Maintain effective communications with Weatherization Crew Leader, Quality Control Inspectors, and Energy Auditors regarding work scope and schedule.
- 5. Maintain close relationship with Weatherization Crew Leader, Energy Auditors and Quality Control Inspectors and assist in problem solving issues which arise from Weatherization retrofit construction.
- 6. Maintain Weatherization vehicles, tools, and equipment.

- 7. Maintain clean, organized, and professional Weatherization building materials/tool storage area. Maintain clean, organized, and professional work site conditions at client homes.
- 8. Assist Weatherization Crew Leader with maintenance of building materials, equipment, and tools inventory.
- 9. Assist Weatherization Crew Leader with maintenance of Weatherization vehicles, equipment, and tools.
- 10. Assist Weatherization Crew Leader with maintaining a clean, organized, and professional Weatherization building materials/tool storage area. Maintain clean, organized, and professional work site conditions at client homes.
- 11. Where appropriate, assist with the unloading, organization and distribution of weatherization materials.
- 12. Perform additional unlisted duties as assigned.

- H. Must be able to interact effectively and professionally with clients and become familiar with available local resources.
- I. Must be able to handle program/client information in a confidential manner.
- J. Must be able to understand the vision and values of our agency and to implement the mission, purpose and goals.
- K. Must be able to operate power tools and equipment in a safe and effective manner.
- L. Must possess or be able to attain/maintain relevant certifications and training, as well as travel to attend relevant periodic training sessions.
- M. Must possess (or attain within a timely manner) a valid Class E Missouri driver's license and appropriate vehicle insurance.
- N. Must be able to pass a background check.
- O. Must have pulmonary function adequate to use a respirator.
- P. Must be able to read, interpret and document any readings illustrated from a four gas meter which determines the health and safety of air in the work space.
- Q. Must be able to operate a blower door.

- R. Must be able to recognize health and safety issues while performing work at a client's home.
- S. Must have the ability to climb ladders, crawl under homes and in attics, and safely lift over fifty (50) pounds.
